October 23, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 23rd day of October, 2006, in the conference room of the Cleveland County Office Building, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of October 16, 2006, and there being no additions or corrections, Bill Graves moved that the minutes be approved. Leroy Krohmer seconded the motion.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated that during this reporting period the average population per day at the Cleveland County Detention Center was 207 prisoners. During this week's period the Sheriff's Office transferred 23 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. No prisoners were transported to the Department of Corrections to serve time for convictions. Five prisoners held for court costs and fines only had hearings and were released on the judges' conditions. Twenty-one people are presently on pre-trial electronic monitoring. Over the past weekend local police officers arrested 28 people on municipal charges. Only 8 of those 28 remained in jail on Monday morning. There were an additional 32 people arrested on state charges during the same weekend with 16 remaining in jail on Monday morning. The Cleveland County Detention Center presently holds 20 prisoners sentenced to Department of Corrections jail time. Several of these should be transported in the next couple of weeks. Thirty-two prisoners are presently serving county jail sentences. The Court System seems to be conducting more hearings and slowly reducing the present high jail court. Mr. Vickers will continue to monitor the jail population and make recommendations when possible.

George Skinner moved, seconded by Bill Graves, to approve the Resolution that will serve to acknowledge the continued support of the Board of County Commissioners of Cleveland County, Oklahoma for the Court Appointed Special Advocate (CASA) program in Cleveland County to provide support in the sum of 43,500.00 for fiscal year 2006-2007.

The Cleveland County Health Department will pay the contractor \$42.50 per hour not to exceed \$10,000,00.
