## October 30, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 30<sup>th</sup> day of October, 2006, in the conference room of the Cleveland County Office Building by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of October 23, 2006, and there being no additions or corrections, George Skinner moved that the minutes be approved. Bill Graves seconded the motion.

Ms. Howard stated two of the bids had whiteout on them and they were not initialed. Upon the request of Ms. Howard, George Skinner moved, seconded by Bill Graves, to accept the bids for County Bid #HD-1305 and to award and/or reject at a later date. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this 7-day reporting period the average population per day at the Cleveland County Detention Center was 188 prisoners. Although this number exceeds the capacity of 177, it is 9 prisoners fewer than the previous week's average of 207. The population decreased from 200 prisoners on Monday, October 23, by 24 prisoners to 176 prisoners on Tuesday, October 24. This large one-day drop in population was due to the Sheriff's Office transport of 10 prisoners who had court proceedings in other jurisdictions, which had placed holds on these inmates. The Courts also held hearings on several more prisoners on Monday, October 23, and released them on personal recognizance bond or lowered their bonds to amounts the prisoners could post. During this week's period the Sheriff's Office transported a total of 22 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. Four prisoners were transported to the Department of Corrections after convictions to serve prison time. From Friday, October 19, until Monday, October 23, 99 people were arrested and booked into the Cleveland County Detention Center. On Monday, October 23, only 27 of those arrested remained in jail. There are presently 20 people who have been released from jail and are on pre-sentence electronic monitoring. The jail presently holds 17 prisoners awaiting final court proceedings and transports to the Department of Corrections for prison sentences. Twenty-seven people are being held at the Cleveland County Detention Center on sentences of county jail time.

Mr. Vickers will continue to monitor the jail population and make recommendations when possible. Mr. Vickers stated that during the past few days there has been a decrease in the jail population, this mornings total was 183.

Bill Graves moved, seconded by George Skinner, to accept the report.
