November 20, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 20th day of November, 2006, in the conference room of the Cleveland County Office Building by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Leroy Krohmer, Chairman Bill Graves, Vice-Chairman George Skinner, Member Dorinda Harvey, Secretary

Others present were: Christine Brannon, Tammy Howard, Neil Vickers, Andy Reiger, Mike McDanel, Jane Cannon, Denise Ellison, Sylvia Martin, Jim Helm, Terran Manning, Eddie Thomason, John Murrell, Lloyd Blaine, Leslie Vise, Danny Vise, Karen Wyatt, and Mac Wyatt.

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of November 13, 2006, and there being no additions or corrections, George Skinner moved that the minutes be approved. Bill Graves seconded the motion.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Upon the recommendation of Tammy Howard, Purchasing Agent, Bill Graves moved, seconded by George Skinner, to award County Bid #HWY-1306 – One-Year (1) Non-Encumbered Contract to provide Materials and Installation of Asphaltic Concrete Base and Surface Coarse (Hot Mix/Hot Laid Asphalt) to the low bidder Silverstar Construction Company. The bid term will be from November 12, 2006, thru November 11, 2007. Ms. Howard stated Silverstar will not go the full term of the bid, it would only be from November 20, 2006, thru May 12, 2007.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Bill Graves moved, seconded by George Skinner, to strike from the agenda discussion, consideration, and/or action to approve the Lease Agreement between the Board of County Commissioners and Oklahoma Department of Human Services – Debbie Holt, Property Management - for property located at 201 S. Jones, Norman, Oklahoma (District Attorney's Child Support Office). Lease is from September 26, 2006, thru June 30, 2007. Total amount of lease is \$22,305.91.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this 7 day reporting period the average population per day at the Cleveland County Detention Center was 187 prisoners. This week's average per day exceeded the maximum set by the Oklahoma Department of Health by 10 prisoners. During this week's period the Sheriff's Office transported 10 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. Two prisoners were transported to the Department of Corrections after convictions to serve prison time. District Judges released six prisoners held for court costs and fines only after new terms were set. From November 10, 2006, thru November 13, 2006, 80 people were arrested and booked into the Cleveland County Detention Center. On Monday November 13th, 31 of those 80 remained in jail. Of the 80 arrested, 29 were arrested on municipal charges. Of the prisoners presently held in the Cleveland County Detention Center, 6 were booked in 2005. The remainder were arrested in 2006. The jail now holds 143 prisoners who were arrested prior to November 1, 2006. The population increase this week is due to the long holiday weekend (Veteran's Day). Mr. Vickers expects these numbers to slowly decrease in the next week. Mr. Vickers will continue to monitor the jail population and make recommendations when possible. Mr. Vickers stated he does suspect that the figures will go up this coming week due to the Thanksgiving 4 day holiday.

George Skinner moved, seconded by Bill Graves, to accept the report. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

George Skinner moved, seconded by Bill Graves, to approve the Contract Amendment for FY06/07 for Juvenile Detention Services between the Cleveland County Commissioners and the Sac Fox Nation Juvenile Detention Center in the amount of \$21.11 per day per child. This amount represents a 15% increase effective November 1, 2006. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Bill Graves moved, seconded by George Skinner, to approve the Contract Amendment for FY06/07 for Juvenile Detention Services between the Cleveland County Commissioners and Oklahoma Juvenile Justice Services, Inc., in the amount of \$23.11 per day per child. This amount represents a 15% increase effective November 1, 2006.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.
