George Skinner moved, seconded by Rusty Sullivan, to accept the bids and to award and/or reject at a later date.

Vice-Chairman Skinner called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this 7-day reporting period the average population per day at the Cleveland County Detention Center was 200 prisoners. This average is 8 less than the previous week. During this week's period the Sheriff's Office transported 10 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. District Judges released one prisoner held for court costs and finds only after new terms were set. At present, 16 prisoners have been placed on electronic monitoring. Over the past weekend from February 16, until Monday morning, February 19, 94 people were arrested and booked into the detention center. Of that 94, 57 were held on state charges with 13 of those remaining in jail on Monday morning. Thirty-seven of the 94 arrested were on municipal charges. The City of Moore arrested 14 with 3 remaining in jail, Noble arrested 1 and none are remaining in jail. Norman arrested 22 with 6 remaining in jail. At the time of this report.

the jail holds 9 municipal prisoners – 8 for Norman and 1 for Moore. Through the four-day holiday weekend, 21 people were arrested for public intoxication and 22 for driving under the influence. Mr. Vickers will continue to monitor the jail population and make recommendations when possible.

David Batton, Assistant District Attorney, stated this is a Federal Program that is conducted through the United States Government to surrounding communities on Tinker Air Force Base. It is a land use study to determine whether or not Tinker Air Force Base is interfering with any public use of land and it includes fly over areas. Cleveland County butts up to the traffic pattern areas so we are included in it and so are all of the other surrounding communities that surround Tinker Air Force Base. Basically what is being done is supporting the operation of Tinker Air Force Base.

Ms. Martin stated that one was being abandoned and then there is another one.

Mr. Batton said it was to name the people that were going to be on the particular two committees. Instead of just doing one blank order they came back with a more specific order.

Tammy Howard, Purchasing Agent, requested that the Board rescind there motion to table the awarding and/or rejecting of County Bid #HD-1317 as the Health Department would like to go an award the bid.

George Skinner moved, seconded by Rusty Sullivan, to rescind the accepting and awarding later of County Bid #HD-1317.
