Chairman Skinner called by discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers was unable to obtain the number of prisoners for Saturday and Sunday, May 19 and May 20, 2007, due to Mr. Vickers being out of town. These figures will be added after receiving the information and an amended report will be prepared. During this 7 day reporting period, without May 19 & 20, 2007, the average population per day of the Cleveland County Detention Center was 206 prisoners. This average was 9 less than the previous week. During this week the City of Norman averaged 6 municipal prisoners per day. The City of Moore averaged 3 prisoners per day. During this week's period the Sheriff's Office transported 28 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. District Judges released 8 prisoners held for court costs and fines after new terms were set. Five prisoners were transported to the Department of Corrections after being sentenced in the Cleveland County Court System. As of Thursday, May 17, 2007, 31 defendants were placed on electronic monitoring. During the past weekend from Friday until Monday morning, 84 people were arrested and booked in the Detention Center. Of the 84, 63 were held on state charges and 21 on municipal charges. Mr. Vickers will continue to monitor the jail population and make recommendations when he can.
