Chairman Skinner called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this 7-day reporting period the average population per day of the Cleveland County Detention Center was 208 prisoners. This average was 3 less than the previous week. During this week the City of Norman averaged 14 municipal prisoners per day and the City of Moore averaged 4 prisoners per day. During this week's period the Sheriff's Office transported 15 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. District Judges released 9 prisoners held for court costs and fines after new terms were set. One prisoner who had been brought in from the DOC was convicted of an additional crime and was returned to the Department of Corrections. There are presently 33 defendants placed on electronic monitoring. During this past weekend from Friday until Monday morning, 75 people were arrested and booked into the Detention Center. Of the 75, 54 were held on state charges and 21 on municipal charges. On Monday morning, 25 of the 75 arrested remained in jail – 15 on state charges and 10 on municipal charges. Of the 75 arrested over this weekend period, 29 were arrested on alcohol related charges – 15 for driving under the influence and 14 for public intoxication. Mr. Vickers will continue to monitor the jail population and make recommendations when he can.
