Chairman Skinner called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this reporting period the average population per day of the Cleveland County Detention Center was 180 prisoners. This average was 9 less than the previous week. During this week the city of Norman averaged 17 municipal prisoners per day and the city of Moore averaged 5 prisoners per day. Municipal prisoners during this period accounted for 12% of the detention center's population. During this week's period the Sheriff's Office transported 14 prisoners to other jurisdictions after hearings were conducted in the Cleveland County court system. Thirteen prisoners who had been convicted and sentenced to prison time were transported to the Department of Corrections or other jurisdictions. District judges released four prisoners held for court costs and fines only after new terms were set. There are presently 25 defendants placed on electronic monitoring. During this past weekend from Friday until Monday morning, 89 people were arrested and booked into the detention center. Of the 89, 61 were held on state charges and 28 on municipal charges. On Monday morning, 38 of the 89 arrested remained in jail—27 on state charges and 11 on municipal charges. Of the 89 arrested over this weekend period, 34 were arrested on alcohol related charges—21 for public intoxication and 13 for driving under the

influence. Mr. Vickers will continue to monitor the jail population and make recommendations as he can.
