The regular scheduled meeting of the Board of County Commissioners was called to order this 9th day of July, 2007, in the conference room of the Cleveland County Office Building by Chairman George Skinner. Roll was called by Tammy Howard, County Clerk/Secretary and those present were:

George Skinner, Chairman Rusty Sullivan, Vice-Chairman Mark Meyer, Member Tammy Howard, Secretary

Others present were: Christine Brannon, Denise Ellison, David Batton, F. DeWayne Beggs, John Murrell, Neil Vickers, Melinda Duke, Peggy Laizure, Sylvia Martin, James Tyree and Jim Helm.

Chairman Skinner began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the special meeting of July 5, 2007, and there being no additions or corrections, Rusty Sullivan moved that the minutes be approved. Mark Meyer seconded the motion.

Chairman Skinner called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this reporting period the average population per day of the Cleveland County Detention Center was 194 prisoners. During this week the City of Norman averaged 18 municipal prisoners per day and the City of Moore averaged 3 prisoners per day. Municipal prisoners during this period accounted for 10% of the detention center's population. During this week's period the Sheriff's Office transported 11 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. District judges released five prisoners held for court costs and fines only after new terms were set. There are presently 28 defendants placed on electronic monitoring. During this past weekend from Friday until Monday morning, 90 people were arrested and booked into the detention center. Of the 90, 54 were held on state charges and 36 on municipal charges. On Monday morning, 36 of the 90 arrested remained in jail—21 on state charges and 15 on municipal charges. Of the 90 arrested over this weekend period, 35 were arrested on alcohol related charges. Of those presently in jail, 45% have been in less than one month. 55% have been in over one month, 34 % have been in over two months, and 7% have been in the detention center over six months. At the time of this report 34 prisoners, or 17% of the total population, have been convicted and are awaiting transport to the Department of Corrections or are serving county time. Mr. Vickers will continue to monitor the jail population and make recommendations as he can.
