Chairman Skinner called for miscellaneous discussion. Captain Sid Stell presented the following report:

The Cleveland County Detention Center held an average of 205 inmates during the first week of
October 2007. The following are the daily inmate counts which were taken at 8 a.m. on each day listed.

Due to overcrowding, McClain County returned all 10 inmates to our jail on October 1, 2007. During this reporting period 122 males and 46 females were booked into the jail compared to 108 males and 29 females during the same week in 2006 for an increase of 58.6% female and 12.9% male book-ins from 2006 to 2007. There were 12 inmates transported to the Department of Corrections and 11 Judgment and Sentences received, processed and sent to the Department of Corrections for future transports. Mr. Stell toured Pottowatomie County Jail with two of the Trustees and the Maintenance Engineer last week. Several repairs have been completed and it appears the jail will be ready to receive prisoners by the first of next week.

Rusty Sullivan asked if the transfer over and expediting from the County Court Clerk was working?

Sid Stell replied yes, that is working excellently.

Chairman Skinner asked if it was a building design flaw where they went through the air conditioning vents at the Pottowatomie Jail the reason why the inmates escaped? Sid Stell replied yes and no, he did not feel like they were really design flaws. They turned out to be design flaws because of the creativity of the inmates. If you stand 3 inmates on each other's shoulders and they are brave enough to do this on a stair rail to get through a 30-foot ceiling, which that is what they did to get out.

David Batton, Assistant District Attorney, ask if Pottowatomie Jail has had an Administration change yet?

Sid Stell replied no, not yet, Carl Pierce is still the acting Administer.

George Skinner stated we should take a hard look at it, before sending any inmates back to Pottowatomie.

Chairman Skinner asked if there was any other miscellaneous discussion? There being no further business to come before the Board, Rod Cleveland moved, that the meeting be adjourned.
