- d. waiving competitive bidding with respect to the sale of such obligations as is required by 60 O.S. Section 176(e); and,
- e. authorizing refunding of prior bonds by the parties to an Interlocal Agreement; and,
- f. authorizing the officers to execute any and all documents relating thereto; and,
- g. authorizing approval of the Cleveland County Home Loan Authority to issue certain obligations as are herein fully described.
