MINUTES

March 17, 2008

The regularly scheduled meeting of the Board of County Commissioners was called to order this 17th day of March, 2008, in meeting room 240 of the Cleveland County Office Building by Chairman George Skinner. Tammy Howard, County Clerk/Secretary, called roll and those present were:
