MINUTES

May 12, 2008

The regularly scheduled meeting of the Board of County Commissioners was called to order this 12th day of May, 2008, in meeting room 200 of the Cleveland County Office Building by Chairman George Skinner. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Chairman Skinner began the meeting with the Pledge of Allegiance.

Rod Cleveland moved, seconded by George Skinner, to approve the minutes of the Regular Meeting of May 5, 2008.

Brenda Wakeman, Assistant Purchasing Agent, requested to award the bid per the bid summary, where the low bidders were not awarded there is an explanation. Chairman Skinner moved, seconded by Rusty Sullivan, to award and/or reject per the bid summary and the Purchasing Department's recommendation for County Bid #HWY-1368 – Non-Encumbered Contract for Bulk Oils, Lubricants & Antifreeze for the County Commissioners. Brenda Wakeman, Assistant Purchasing Agent, requested the bid be awarded to Southwest Trailer & Equipment, due to past experience with the Company. They are not the low bid, but are the second lowest and overall best bid and would like to award the bid for delivered price of \$32,450.00 with option #4 at \$500.00. District #1 would like to purchase one (1) each trailer and District #3 would like to purchase two (2) each trailers.
