Per the recommendation of Denise Heavner, County Assessor, George Skinner moved, seconded by Rusty Sullivan, to reject all bids and to bid at a later date for County Bid #CA-1372 – Proposals for a qualified Geographic Information System (GIS) consultant to provide professional services to upgrade and improve the way the County maintains land parcel information for the Cleveland County Assessor's Office.

Per the recommendation of Melinda Duke, Purchasing Agent, Rusty Sullivan moved, seconded by Rod Cleveland, to award to the low bidders Blaco Construction and Silver Star Construction, County Bid #HWY-1373 – Six-Months (6) Non-Encumbered Contract to provide Materials and Installation of Asphaltic Concrete Base and Surface Coarse (Hot Mix/Hot Laid Asphalt). The bid term will be from June 10, 2008 through December 9, 2008. The vote was: George Skinner, yes; Rusty Sullivan, yes; Rod Cleveland, yes. Motion carried.

Per the recommendation of David Batton, Assistant District Attorney, to approve contingent on receiving a grant or other agencies to join in on the contract to help with the cost. If none of those contingency's happen then the County can back out of the contract. George Skinner moved, seconded by Rod Cleveland, to approve the contingent contract between the Board of County Commissioners and Pictometry International Corporation for Air Borne Digital Images of earth surface area in Cleveland County for one (1) year commencing prospectively on or about July 1, 2008 through June 30, 2009 with option to renew for five (5) consecutive years under the same terms and conditions.
