## **MINUTES**

June 23, 2008

The regularly scheduled meeting of the Board of County Commissioners was called to order this 23rd day of June, 2008, in meeting room 240 of the Cleveland County Office Building by Chairman George Skinner. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Chairman Skinner began the meeting with the Pledge of Allegiance.

Rod Cleveland moved, seconded by Rusty Sullivan, to approve the minutes of the Regular Meeting of June 16, 2008.
