## MINUTES

## November 3, 2008

Chairman Skinner began the meeting with the Pledge of Allegiance.

Rod Cleveland moved, seconded by Rusty Sullivan, to approve the Maintenance Agreement between the Cleveland County Clerk and Sooner Copy Machines, Inc. for a wide format copier, model #KIP-1900, Serial #10600318, monthly cost will be .05¢ per sq. ft. until the County Clerk's Office stocked paper and toner run out, then the price increase to .08¢ per sq. ft. which will include parts, drum, labor, toner and paper. The contract will be effective on the approval date through June 30, 2009.

Rod Cleveland moved, seconded by Rusty Sullivan, to approve the Renewal Service Agreement between the Cleveland County Treasurer and R.K. Black, Inc. for (2) Kyocera Printers, Model #KM5035, S/N #M3011997 and #M3011996, with a per copy charge of \$0.0125 to be billed quarterly. The agreement will be in effect from October 1, 2008 through September 30, 2009.

Chairman Skinner called for the discussion, consideration, and/or action to rescind the approval to pay invoices received from Pottawatomie County for housing inmates for the months of July and August, 2008 approved on the October 14, 2008 agenda.

David Batton, A.D.A., stated the Pottawatomie County invoices were wrong and the following week after the approval Pottawatomie County submitted corrected invoices. The problem was the Sheriff's Office and Pottawatomie County numbers did not match up. Rusty Sullivan stated he had called Pottawatomie County to verify the new numbers were correct and the Sheriff's Office had done the same.

Rusty Sullivan moved, seconded by Rod Cleveland, to rescind the approval to pay invoices received from Pottawatomie County for the months of July and August, 2008 approved on the October 14, 2008 agenda.

The vote was: George Skinner, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion Carried.

Chairman Skinner called for the discussion, consideration, and/or action to approve the payment of invoices received from Pottawatomie County for housing inmates for the months of July, 2008 for the amount of \$7,476.00 and August, 2008 for the amount of \$12,488.00. Rusty Sullivan stated he verified the numbers on the new invoices are correct.

David Batton, A.D.A., replied in the affirmative also.

Rod Cleveland asked if there has been a comparison on the cost of Pottawatomie County housing the inmates versus Cleveland County housing them?

Rusty Sullivan answered the numbers would be significantly different.

Rod Cleveland moved, seconded by Rusty Sullivan, to approve the payment of invoices received from Pottawatomie County for housing inmates for the months of July, 2008 for the amount of \$7,476.00 and August, 2008 for the amount of \$12,488.00.

Per the recommendation of David Batton, A.D.A., Rusty Sullivan moved, seconded by Rod Cleveland, to approve the Jail Services Agreement between the Board of County Commissioners of Cleveland County and Pottawatomie County Public Safety Center Trust for the housing of inmates. The contract will cover from five (5) inmates up to twenty (20) inmates for the amount of \$32.00 per inmate per day. If additional space is needed, the cost of incarceration will be at the same rate of \$32.00 per inmate per day. The contract will be in effect from the approval date through June 30, 2009.

Chairman Skinner called for miscellaneous discussion.

Rod Cleveland stated he had received a few phone calls concerning the upcoming vote for proposed sales tax for the construction of the new jail. Mr. Cleveland also stated there would be more information forth coming to the public and wanted everyone to know they are welcome to come to any of the meetings. Mr. Cleveland went on to say once the website is up there would be information posted there, the newspapers have been providing ample information to the public and if anyone had questions they could call the Commissioner's Office anytime. Mr. Cleveland would also like to have all the other County Officials together in a meeting and show them a presentation of all the information available so they can also answer any questions to their constituents.

George Skinner stated he has also received numerous phone calls supporting the sales taxes. Rod Cleveland replied that does seem to be the overall view of the public.

Rusty Sullivan stated one of the important aspects of this tax proposal is 30% to 35% incarcerated are not residents of this County and a sales tax would help our citizens to not be the only ones shouldering the tax burden.

There being no further business to come before the Board, Rusty Sullivan moved, that the meeting be adjourned. Rod Cleveland seconded the motion. The vote was: George Skinner, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion Carried.
