January 26, 2009

The regularly scheduled meeting of the Board of County Commissioners was called to order this 26th day of January, 2009, in meeting room 240 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Chairman Cleveland began the meeting with the Pledge of Allegiance.

George Skinner moved, seconded by Rusty Sullivan, to approve the table of the Regular Meeting of January 20, 2009.

Chairman Cleveland called for the discussion, consideration, and/or action on the employment, hiring, appointment, or promotion to the position of Cleveland County Assessor to finish term due to the pending retirement of Denise Heavner effective on February 28, 2009.

Discussion took place about the possibility of promoting David Tinsley to finish out the term. Rusty Sullivan stated Ms. Heavner's 1st Deputy, David Tinsley, had been employed by the County one-year longer the Ms. Heavner. Mr. Sullivan went on to say by promoting Mr. Tinsley it would be a seamless transition.

Rusty Sullivan moved, seconded by George Skinner, to appoint Mr. David Tinsley to serve out the reminder of Ms. Denise Heavner's term as County Assessor.
