March 16, 2009

The regularly scheduled meeting of the Board of County Commissioners was called to order this 16th day of March, 2009, in meeting room 240 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Howard, County Clerk/Secretary, called roll and those present were:

The agreement shall be in effect for one (1) year, commencing from the bid award date through and including twelve (1) months, with the option to re-new up to three (3) years on an annual basis to Adam's Towing Inc. - Zone #1 and Quality Towing Service, Inc. - Zones 2, 3 & 4 bids being the over all best bids.

The Book-In comparison for this week:

Twelve people were out on ankle monitors. 66 people were held on Misdemeanor and 229 on Felony charges. 64 people were held on Municipal charges. 7 Juveniles were held. 63 people were here for holds. No Inmates were transported to DOC.

The proposed contract will be for medical staffing and administration services, sole supplier and/or coordinator of the health care delivery system for the Cleveland County Detention Center for the amount of \$122,500.00, April 1, 2009 through June 30, 2009.

Allowing the Tax Commission to designate a Local tax Coordinator for the Commission and authorizing a retention fee per 68 O.S.§ 2702 This Agreement being effective April 1, 2009 until March 31, 2010 which will be renewed for successive additional one year terms under the same terms and conditions during the life of the sales tax resolution.
