MINUTES

July 6, 2009

The regularly scheduled meeting of the Board of County Commissioners was called to order this 6th day of July, 2009, in meeting room 240 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Rod Cleveland, Chairman Rusty Sullivan, Vice-Chairman George Skinner, Member Tammy Howard, Secretary

Others present were: Christine Brannon, David Batton, David Tinsley, Joe Lester, Melinda Duke, Peggy Laizure, James Tyree, Dan Cary, Denise Ellison and Anette Pretty.

Chairman Cleveland began the meeting with the Pledge of Allegiance.

Rusty Sullivan moved, seconded by George Skinner, to approve the minutes of the Regular Meetings of June 29, 2009 and July 1, 2009.

The vote was: George Skinner, yes; Rusty Sullivan, yes; Rod Cleveland, yes. Motion Carried.

Rod Cleveland moved, seconded by George Skinner, to table the awarding and/or rejecting of County Bid #SHE-1418 – One-Year (1) Non- Encumbered Contract to provide Commissary Services for the Cleveland County Sheriff's Office. Agreement shall be in effect for one (1) year, commencing from the bid award date through and including 12 months, with the option to re-new up to three (3) years on an annual basis. Rusty Sullivan moved, seconded by George Skinner, to table the discussion, consideration, and/or action to approve the Interlocal Agreement between the Board of County Commissioners and Greg Mashburn, District Attorney, for District Attorney District #21, for aid in payment of costs for legal advice and/or representation for County Officers by the Civil Division of the District Attorney's Office from July 1, 2009 thru June 30, 2010. The vote was: Rod Cleveland, yes; George Skinner, yes; Rusty Sullivan, yes. Motion Carried.

Upon the recommendation of David Batton, Assistant District Attorney, Rusty Sullivan moved, seconded by George Skinner, to approve the agreement between the Board of County Commissioners and Absentee Shawnee Tribe replacing the Bridge located at Buckhead Creek, with the addition of a waiver. The vote was: George Skinner, yes; Rusty Sullivan, yes; Rod Cleveland, yes. Motion Carried.

Rod Cleveland moved, seconded by Rusty Sullivan, to table the discussion, consideration, and/or action regarding a proposal from the City of Norman about converting parking meters to increase parking time from one hour to two hours.

George Skinner moved, seconded by Rusty Sullivan, to approve the Contract between the Cleveland County Health Department and Joyce Gibson for Directly Observed Therapy (DOT) and related services to tuberculosis (TB) patients at a rate of \$6.00 per visit and mileage in accordance with the State Travel Reimbursement Act (STRA) with is currently \$.55 per mile for a maximum reimbursement of \$12,713.00. Contract period will be from July 1, 200 through June 30, 2010.

Rusty Sullivan moved, seconded by George Skinner, to approve the Contract between the Cleveland County Health Department and Timothy G. Mastin for Directly Observed Therapy (DOT) and related services to tuberculosis (TB) patients at a rate of \$6.00 per visit and mileage in accordance with the State Travel Reimbursement Act (STRA) with is currently \$.55 per mile for a maximum reimbursement of \$12,713.00. Contract period will be from July 1, 2009 through June 30, 2010.
