The City of Norman is requesting change due to the frequency of accidents at the intersection and will be responsible the installation and maintenance of traffic control devices.

This program is a cooperative effort of the Cleveland County Health Department, NorthHaven Day School, Norman Public Schools and Early Foundations. The program is for children suspected or diagnosed Autism Spectrum Disorder. The agreement is for a maximum of \$10,000.00, amount not to exceed \$10.00 per service hour and mileage in accordance with the State Travel Reimbursement Act (STRA), which is currently \$0.55 per mile as currently defined by the STRA, as the travel rate is adjusted this agreement will likewise be adjusted.
