November 7, 2011

The regularly scheduled meeting of the Board of County Commissioners was called to order this 7th day of November, 2011, in meeting room 200 of the Cleveland County Office Building by Chairman George Skinner. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Rod Cleveland moved, seconded by Rusty Sullivan, to Approve the minutes of the Regular Meeting of October 31, 2011.

The vote was: Rusty Sullivan, yes; George Skinner, yes; and Rod Cleveland, yes. Motion carried.

Upon the recommendation of Purchasing Agent Melinda Duke, George Skinner moved, seconded by Rusty Sullivan, to award County Bid #SHE-1528 – One-Year (1) Non-Encumbered Contract for Inmate Clothing for Cleveland County to Robinson Textiles Inc. The bid term will be in effect for one (1) year commencing from bid award date through and including 12 months.

All terms and conditions will remain the same. The renewal period will be from November 15, 2011 through November 14, 2012.

George Skinner moved, seconded by Rod Cleveland, to Approve a Maintenance & Repair Agreement between United Engines and Cleveland County Health Department for a MTU Onsite Energy 750 KW generator located at 424 South Chestnut, Moore, OK 73160. The Health Department will pay maintenance costs of \$1,500.00 for one Annual Full Service and one Semi-Annual Inspection, and \$1,000.00 for one Generator Load Bank Test when concurrent with other inspection for a total price per year of \$2,500.00.

George Skinner moved, seconded by Rod Cleveland, to Approve the resolution relating to the incurring of indebtedness by the Trustees of the Cleveland County Educational Facilities Authority to be accomplished by the issuance of lease revenue bonds, notes or other evidences of indebtedness on a tax-exempt or taxable basis in the aggregate principal amount of not to exceed \$7,500,000 to provide funds to Independent School District No. 70, Cleveland County, Oklahoma ("Little Axe Public Schools" or the "District") required to complete the acquisition, construction, equipping, repairing and remodeling of school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites; establish a reserve fund, capitalize interest and pay costs of issuance and all matters related thereto, including but not limited to the waiver of competitive bidding thereof; and declaring an emergency.
