November 14, 2011

The regularly scheduled meeting of the Board of County Commissioners was called to order this 14th day of November, 2011, in meeting room 200 of the Cleveland County Office Building by Chairman George Skinner. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Rod Cleveland moved, seconded by Rusty Sullivan, to Approve the minutes of the Regular Meeting of November 7, 2011.

Upon the recommendation of Assistant Purchasing Agent Brenda Wakeman, George Skinner moved, seconded by Rusty Sullivan, to Award County Bid #EB-1530 – One Year (1) Non-Encumbered Contract for the Printing of Election Ballots for the County Election Board to Royal Printing. The bid term will be from November 15, 2011 through November 14, 2012. Although Royal Printing is not the lowest bidder, it is the best bid, Election Board Secretary Jim Williams said.

Bids for the ballot printing contract were received from two vendors: Royal Printing Company (Oklahoma City, OK) and Mid-West Printing Company (Sapulpa, OK).

We acknowledge that the lowest bidder is Mid-West Printing and that in some elections the cost differential could be considered substantial (see attached bid sheet.) However, several factors should be considered when determining the "lowest and best" bid.

The Cleveland County Election Board has a long-standing, successful relationship with Royal Printing Company for supplying our election ballots. Not only have we never had a problem with their deliverables, but we have come to rely upon the peace of mind that they provide us regarding the accuracy, security and timeliness of printing and delivering our election ballots. In addition, we find their responsiveness and attention to detail to be unmatched in the industry.

The state of Oklahoma is undergoing a major facelift in 2012 regarding voting equipment and ballot printing. The new system requires digital printing rather than offset printing, which has never been a requirement in Oklahoma. Royal Printing Company has installed new equipment and implemented appropriate procedures to accommodate the new printing requirements. They have been awarded the statewide ballot printing contract for the State Election Board. Mid-West Printing is currently in the process of implementing digital printing, but our understanding is that our ballots would be produced and delivered from a third-party owned, contracted facility.

Our agency remains committed to being a good steward of the taxpayer's money. While we diligently and sincerely strive to save money whenever possible and practical, ballot printing is not something on which we can take any unnecessary risks -- especially in a critical election year full of many changes and accompanying new challenges. After careful consideration of the options at hand, my recommendation is that the bid from Royal Printing is in fact the "lowest and best" at this time.
