## **BOARD OF COUNTY COMMISSIONER'S**

## MINUTES May 14, 2012

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:03 a.m. this 14th day of May, 2012, in meeting room 200 of the Cleveland County Office Building by Vice Chairman Rod Cleveland. Tammy Howard, County Clerk/Secretary, called roll and those present were:

George Skinner, Chairman, was absent.

Others present were: Assistant District Attorney David Batton, Melinda Duke, Gayla Sukenis, Rhett Burnett, William Francis, John Angier, Buzz McDonald, Greg Scott and Peggy Laizure.

Rod Cleveland recognized John Angier, who was videotaping the meeting. Cleveland asked his name, why he was taping and his web address. Angier said he was OK1news and said he would email his address. Cleveland asked three more times for web address for the minutes and threatened to hold Angier in contempt and have the sheriff or Undersheriff Rhett Burnett to remove him from the meeting.
