BOARD OF COUNTY COMMISSIONER'S

MINUTES July 16, 2012

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 16th day of July, 2012, in meeting room 200 of the Cleveland County Office Building by Vice Chairman Rusty Sullivan. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Rusty Sullivan moved, seconded by Mark Meyer, to approve the Lease between Cleveland County Facilities Authority and Crossroads Youth and Family Services for 9,899 square feet of space leased at 1650 W. Tecumseh Road from July 1, 2012 through June 30, 2013 in the amount of \$22,176.00.

Tammy Howard said it was the same contract as last year and the cost varied depending on if the documents were on disk or microfilm, etc. (Clerk's note: The end date of the contract is June 30, 2013.)

Wes and I met with the City of Norman staff (Steve Lewis, Terry Floyd, Shawn O'Leary & Jeff Bryant) on Tuesday about the purposed parking lot off of Eufaula and the current parking lot off Symmes.

I wanted to meet with the city to get an update on the status of the closure of the ally and to get their input. I expressed my reason for wanting to close the ally so to make the two lots seamless as one. Wes also went over the aesthetic improvements. The city staff really appreciated what we are doing. The city staff's opinion was that applying for closure was a better idea than vacating the ally.

Proceeding with scheme "B" and at the same time applying for the closer of the ally can be done simultaneously. We do not need to wait on the approval of the application. If and when the closer application is approved we can do a change order to make access between the two lots.

Handicap parking was talked about also. One thought that was talked about was assigning handicap parking in what is now the "old detention compound." The compound could be reconfigured to accommodate 5 to 7 handicap parking spots and leave room to fence off a secure area for deputies to bring detainees for court. This would be a secure for Cleveland County employees and these employees could have their county id's reprogramed to allow access to the north door.

Below are the discussion points that Wes and I worked out. EST, Inc. will need to finalize the plans using the scheme "B"

- Scheme 'B' will be submitted for review and approval
- Simultaneous application for 'Closing' not *vacating* of the existing alley will be submitted by the Trust through the City of Norman
- Re-design of all handicap parking to be considered for review and approval to be located in
 the current paving section of the existing drive lane to the abandoned jail sally port entrance
 entering north from Eufaula Street to satisfy the required ADAG percentages for all parking
 spaces in the Contract Document improvements
- Reposition West Elevation 'South' Parking Lot entrance to comply with the City of Norman standards relative to the intersection of Jones/Symmes Street
- The Pelco Ornamental Lighting fixtures will be submitted under base bid with the Holophane and Lithonia fixtures submitted in the Contract Documents as an Add/Deduct Alternate

Rusty Sullivan said that they were real busy in the middle of road season.

Sheriff Joe Lester gave Rusty Sullivan a copy of a jail report that noted as of today's date, the head count of prisoners in the F. DeWayne Beggs Detention Center is 381. A copy of the memo follows.

As of today's date the head Count of the prisoners in the F. DeWayne Beggs Detention Center is currently at 381.



HUMAN INTEREST STORY:

"Maria" is a 15 year old girl who was originally placed in our shelter to wait for a foster home. Prior to coming here she had been "AWOL" for 3 months and had a history of running away a lot from placements. When she first arrived in our shelter, "Maria" was very sullen. She barely spoke to anyone and would just sit on the couch all day. The first few days she was here, she wouldn't eat or bathe. It was difficult to get her to do anything. "Maria" ended up being in this shelter for 3 months. During that time we saw her blossom from a couch potato to a smiling, laughing talkative young woman. The girl who would barely move became very outgoing, interacting well with peers and staff. The girl who would not bathe began to take pride in her appearance and was very helpful in keeping the shelter clean. The girl who would not eat became very helpful in the kitchen and developed a healthy appetite.

When she finally began opening up to us, she let us know of all the placements that she had been in, that she had not felt like she could trust anyone. She let us know that she felt safe here and felt that the staff here really cared about her. She admitted to having thoughts of running away earlier during her shelter stay. Once a foster home became available, she was sad and reluctant to leave. Staff let her know to do her part to make the placement work. She left tearfully. We have been able to speak with her caseworker on several occasions and to this day, "Maria" remains in the foster home and is doing well. She has also called occasionally to let us know how she's doing.
