BOARD OF COUNTY COMMISSIONER'S

MINUTES August 13, 2012

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 13th day of August, 2012, in meeting room 200 of the Cleveland County Office Building by Chairman Rod Cleveland.
