BOARD OF COUNTY COMMISSIONER'S

MINUTES JANUARY 7, 2013

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 7th day of January, 2013, in meeting room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Rusty Sullivan moved, seconded by Rod Cleveland, to approve the Minutes of the Regular Meeting of December 31, 2012.
