## BOARD OF COUNTY COMMISSIONER'S MINUTES JANUARY 28, 2013

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 28th day of January, 2013, in meeting room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Darry Stacy moved, seconded by Rod Cleveland, to table the Minutes of the Regular Meeting of January 22, 2013.
