FEBRUARY 11, 2013

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 11th day of February 2013, in meeting room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Darry Stacy moved, seconded by Rod Cleveland, to approve the Minutes of the Regular Meeting of February 4, 2013.

- 7. Approve payment of purchase orders and review by department in BOCC meeting during item discussion.
- 8. Add a prayer to precede the BOCC being called to order.
- 9. Move the BOCC meeting time from 9:00 a.m. to 1:00 p.m.
