BOARD OF COUNTY COMMISSIONER'S Minutes

FEBRUARY 25, 2013

The regularly scheduled meeting of the Board of County Commissioners was called to order at 9:00 a.m. this 25th day of February 2013, in the meeting Room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Darry Stacy moved, seconded by Rusty Sullivan, to approve the minutes of the Regular Meeting of February 19, 2013.

Upon the recommendation of Assistant Purchasing Agent Keri Lyles, Rod Cleveland moved, seconded by Darry Stacy, to table County Bid #HWY-1592 – Non-Encumbered Contract for Road Oils, Emulsions and Sealants for the County Commissioners. The bid term will be from March 7, 2013 through June 6, 2013.

The bid term will be from March 16, 2013 to March 15, 2014, with the option to renew up to two (2) years on an annual basis.
