MONDAY, JULY 15, 2013 AT 1:00 P.M.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 15th day of July 2013 in the meeting Room 200 of the Cleveland County Office Building by Vice-Chairman Darry Stacy. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Rusty Sullivan, Chairman, was absent.

Others present were: Assistant District Attorney Jim Robertson, Wanda Danley, Linda Atkins, Joy Hampton, George Mauldin, Valerie Mattheus, Keri Lyles, Melinda Duke, Annette Pretty and Holly Armstrong.

After the reading of the minutes of the regular meeting of July 8th, 2013, and there being no additions or corrections, Rod Cleveland moved that the minutes be approved. The motion was seconded by Darry Stacy.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Richey Fink, yes. Motion carried.

A. Items of Business: Discussion, Consideration and/or Action regarding the following:

- 1. Rod Cleveland moved, seconded by Richey Fink, to approve the Professional Services Agreement between the Cleveland County Assessor's Office and Colorado Custom Ware Inc. for annual support services for the period July 1, 2013 through June 30, 2014 in the amount of \$73,372.00.
