## BOARD OF COUNTY COMMISSIONER'S MINUTES August 05, 2013

Linda Atkins, Deputy County Clerk, led in prayer and the pledge of allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 5th day of August 2013 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Others present were: Assistant District Attorney Jim Robertson, Assistant District Attorney Heather Darby, Wanda Danley, Linda Atkins, Joy Hampton, Gayla Sukenis, Valerie Mattheus, Patty Cox, Keri Lyles, Melinda Duke, Annette Pretty and Carol Cline.

After the reading of the minutes of the regular meeting of July 29, 2013, and there being no additions or corrections, Darry Stacy moved that the minutes be approved. The motion was seconded by Rod Cleveland. The vote was: Rod Cleveland, yes; Rusty Sullivan, yes; Darry Stacy, yes. Motion carried.

## A. Old Business:

- Upon the recommendation of Assistant Purchasing Agent Keri Lyles, Rusty Sullivan moved, seconded by Rod Cleveland, to table until a later date the awarding and/or rejecting of the bids for **Bid-HWY-1622**-Six-Month (6) Non-Encumbered Contract for Tires and Tubes. The bid term will be from September 5, 2013 through March 4, 2014. The vote was: Rusty Sullivan, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.
- Upon the recommendation of Assistant Purchasing Agent Keri Lyles, Rusty Sullivan moved, seconded by Darry Stacy, to table until a later date the awarding and/or rejecting of the bids for **Bid-HWY-1623**-Three-Month (3) Non-Encumbered Contract for Road Oils, Emulsions and Sealants for the County Commissioners. The bid term will be from September 7, 2013 through December 6, 2013.

- C. There was no New Business to come before the Board for discussion.
- D. Commissioner's Discussions regarding County Business: Rusty Sullivan said road season was put off last week as a result of the flooding, and added that District #3 is about to get all the losses under control. He said that resurfacing projects will be underway by midweek if all goes well.

Darry Stacy said that District #2 will be completing the debris removal by the 15th of August. He said that things are looking very good on the east side of the County and all the help and support from the various volunteer groups, the church groups and the Red Cross was greatly appreciated. Commissioner Stacy said that without all the outpouring of assistance and support there was no way they could be at the point they are now and thanked everyone involved.

Rod Cleveland discussed the information he had received regarding the Webinar training costs. He said that their proposal for the size of Cleveland County is \$245.00 per month, which included an additional cost of \$1,500.00 for a setup fee for unlimited users. Mr. Cleveland said that the County has approximately 350 employees that will benefit by the new training system. He said that this information was forwarded to Undersheriff Rhett Burnett and Chief Carrie Davis, Cleveland County Sheriff's Department, and if it proves useful to them, they are invited to use the new technology. He suggested that they schedule some meetings beginning this week.

Also, Rod Cleveland said that the County Commissioners recently attended the Association of County Commissioners of Oklahoma's Safety Conference, which is a very important event because it saves taxpayers money through the promotion of safety awareness. He said that approximately thirty (30) county employees were recognized and received safety jackets.

Darry Stacy said they had an incredible speaker this year that really provided a personal touch on safety and added that he came away very impressed. Rod Cleveland agreed that there is never enough talk regarding safety. He said that safety training is not exclusive to the Deputies and road crews, it is for everyone.
