## **BOARD OF COUNTY COMMISSIONERS**

## MINUTES

# AUGUST 12, 2013

The Honorable Judge Stephen Bonner, Associate District Judge of the District Court of Cleveland County, led in prayer and pledge of allegiance.

The regularly scheduled meeting of the Board of County Commissioners was called to order at 1:00 p.m. this 12<sup>th</sup> day of August 2013 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. Linda Atkins, Deputy County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the meeting of August 5, 2013, and there being no additions or corrections, Rod Cleveland moved that the minutes be approved. The motion was seconded by Darry Stacy.

## A. Old Business:

 Upon the recommendation of Purchasing Agent Melinda Duke, Rusty Sullivan moved, seconded by Darry Stacy, to table the awarding and/or rejecting of the bids until a later date for **BID#-HWY-1622**-Six- Month (6) Non-Encumbered Contract for Tires and Tubes. The bid term will be from September 5, 2013 through March 4, 2014. The vote was: Rusty Sullivan, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried. Upon the recommendation of Purchasing Agent Melinda Duke, Rusty Sullivan moved, seconded by Rod Cleveland, to table the awarding and/or rejecting of the bids until a later date for **BID#-HWY-1623**-Three- Month (3) Non-Encumbered Contract for Road Oils, Emulsions and Sealants for the County Commissioners. The bid term will be from September 7, 2013 through December 6, 2013. The vote was: Rusty Sullivan, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.

- Chairman Rusty Sullivan called for Presentation of Safety Awards, as follows:

  - b.Undersheriff Rhett Burnett, Cleveland County Sheriff's Department presented the following safety awards: Captain Kevin Brandon, 5 years; Dispatcher Anthony Henthorn, 5 years; Dispatcher Jonathan Leech, 5 years; Deputy Terry McCrackin, 5 years; Deputy William Thomas, 5 years;
  - c.David Tinsley, County Assessor, presented the following awards: Sam Woodfork, 25 years; Cheryl Pack, 25 years; Billijo Ragland, 25 years; Jannis Allen, 25 years; Marianne Kennedy, 20 years; Donna Morgan, 15 years; and Jennifer Frank , 15 years;
  - d.County Treasurer's Office, presented by Mona Nelson, Deputy: Lori Kelleher, 10 years; and Michelle Newburg, 10 years;
  - e. Chairman Rusty Sullivan listed the names of the employees that received jackets and are as follows: Jannis Allen, Cheryl Pack, Alma Berger, Gary Jester, Billijo Ragland, Melanie Wilke and Sam Woodfork.
  - f.District #1 Commissioner Rod Cleveland stated that he had several employees that qualified for safety awards: Gary Jester, 30 Years; Billy Dyer, 10 Years; Joseph C. Inman, 5 Years; Earnest McGee, 5 Years; Brandon Miller, 5 Years. He said that they are not here today because they are working on the roads. He will be making presentations at his barn. He reminded everyone how important it is to be safety conscious.
  - g. District #3 Commissioner Rusty Sullivan stated that he had three employees that qualified for safety awards and added that they are working on the roads as well. He said that they are so far behind on their road season due to the weather and will be doing their presentations at the barn. Mark Bugher, Richie Fink and Rick Young are being recognized for

5 year safety awards. Melanie Wilke, Administrative Assistant, is given a 30 year safety award and a jacket.

- h.Chairman Sullivan said that Commissioner's Executive Administrative Assistant, Denise Ellison, is presented with a 20 year safety award and is celebrating her birthday today as well.
- 2. Chairman Rusty Sullivan said that on behalf of Cleveland County, Pauline Best and her Volunteer Group are being awarded a Certificate of Appreciation and Recognition for their efforts in making approximately 100 quilts to be distributed free to people who suffered losses in the recent May 2013 Tornadoes. He said that the numerous quilts displayed around the room were made by a group of ladies out of Bakersfield, California. Many in her quilting group have links to Oklahoma. Ms. Best told him that she had lived for more than fifty years on a dirt road in Rosedale and that she is now eighty (80) years old. Quilts made by this group have been sent to different disaster victims around the country such as Hurricane Katrina. He said that as anyone can see the quilts are a lot of work. He added that Ms. Best would sometimes arise at 5:00 a.m. in the morning and start sewing on these quilts and she wants to make sure that they get into the right hands. Chairman Sullivan asked for input on how to proceed in distributing the quilts.

Darry Stacy suggested that the quilts be given to Emergency Manager George Mauldin to distribute to the tornado victims since Mr. Mauldin is part of the long term recovery group for Cleveland County and serves as Chairman of that committee.

He explained that they are putting together house warming boxes for victims that are moving back into new structures. He said that other groups have donated similar articles and these quilts can be used as house warming gifts.

Commissioners Sullivan and Cleveland were in agreement with Mr. Stacy's suggestion.

Chairman Sullivan said that Cleveland County appreciates **Pauline Best and the Volunteer Group** for their hard work and stated that each Commissioner will sign the Certificate of Appreciation and Recognition.

- Darry Stacy moved, seconded by Rusty Sullivan, to approve the Agreement for Pre-Trial Mental Health Pre-Trial and Community Service Court Services between the Cleveland County Board of County Commissioners and Cleveland County Pre-Trial Services, LLC for Fiscal Year 2013-2014. - Rod Cleveland moved, seconded by Darry Stacy, to approve the proceeds of a grant donation from OEC Foundation Inc. in the amount of \$1,500.00 given to the Cleveland County Sheriff's Office to purchase an AED Defibrillator. - 5. Darry Stacy moved, seconded by Rod Cleveland, to approve the Contract for Services between the Cleveland County Health Department and Ozarka Water Company for Dispenser and Water. The Contract will run from July 1, 2013 through June 30, 2014 for \$6.45 per 5 gallon bottle of water, \$7.00 refundable bottle deposit on each bottle, and \$12.50 monthly lease per cooler. Application for grant is to fund Court Service Officer position to supervise offenders convicted of domestic violence. This position allows for probation term instead of incarceration in the County Jail. A grant application has been previously approved in 2004-2012 and the County does not have to provide matching funds.
