BOARD OF COUNTY COMMISSIONER'S

MINUTES

OCTOBER 7, 2013

Doyle Pryor, Pastor of Bethel Baptist Church, led in Prayer and Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 7th day of October 2013 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. Roll was called by Tammy Belinson, County Clerk/Secretary, and those present were:

After the reading of the minutes of the regular meeting of September 30, 2013, and there being no additions or corrections, Darry Stacy moved that the minutes be approved. The motion was seconded by Rod Cleveland.

The vote was: Rusty Sullivan, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.

A. Old Business:

1. Upon the recommendation of Melinda Duke, Purchasing Agent, Rusty Sullivan moved, seconded by Rod Cleveland, to table the awarding and/or rejecting of the bids for BID#-COM-1626-Provide Website Design Services to redesign and incorporate the County's websites into a Content Management System until a later date.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion carried.

2. Upon the recommendation of Melinda Duke, Purchasing Agent, Rusty Sullivan moved, seconded by Darry Stacy, to **table** the awarding and/or rejecting of the bids for **BID#-SHE-1629-**One (1) Year Non-Encumbered Contract to provide an Inmate Telephone System for the Cleveland County Sheriff's Office until a later date. This agreement shall be in effect for one (1) year, commencing from the bid award

date through and including 12 months, with the option to re-new up to two (2) years on an annual basis.

B. Items of Business:

Rod Cleveland moved, seconded by Darry Stacy, to **approve** the **Renewal**Agreement between The Board of County Commissioners of Cleveland County on behalf of the Cleveland County IT Department and Windstream Communications for Customer Service, Dynamic IP, and T1 Bundle for the period September 1, 2013 through June 30, 2014.

2. Rod Cleveland moved, seconded by Darry Stacy, to **approve** the **Application** for Permit by Oklahoma Natural Gas on a proposed 2" Natural Gas Pipeline Crossing on Indian Hills Road, the SE/4 of Section 33-T10N-R3W in Cleveland County District #1.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion carried.

3. Rusty Sullivan moved, seconded by Darry Stacy, to **approve** the **Application** for Permit by Oklahoma Natural Gas on a proposed 4" Natural Gas Pipeline Crossing on 48th Avenue Southeast NE/4 of Section 2-T7N-R2W in Cleveland County District #3.

The vote was: Rod Cleveland, yes; Rusty Sullivan, yes; Darry Stacy, yes. Motion carried.

- 4. Assistant District Attorney Jim Robertson stated that last week he reviewed the documents pertaining to this particular agenda item, and was somewhat confused after reviewing the documents as to what type of line that they were proposing to lay, because they failed stipulate that information in the documents. He recommended that it either be tabled or stricken from the agenda until a later date for further clarification. Therefore; Rusty Sullivan moved, seconded by Darry Stacy, to strike the Application for Permit by Windstream Communications to dry bore from the south side to north side and set new pod on north side next to the right-of-way approximately 3,760 feet east from the SE/4 of Section 8-T6N-R1E and the NE/4 of Section 17-T6N-R1E in Cleveland County District #3 from the agenda. The vote was: Rusty Sullivan, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.
- 5. Darry Stacy moved, seconded by Rod Cleveland, to **approve** the **Agreement** between Cleveland County Health Department and Absolute Data Shredding for document destruction services for the Norman and Moore Offices at a rate of \$18.75 per secure console (7 total) and \$40.00 per secure poly cart (3 total), for a total of \$250.00 per

month. Special purge is \$5.00 per letter box and \$7.50 per legal box. Service will be every 4 weeks for the period October 1, 2013 through June 30, 2014. The vote was: Darry Stacy, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion carried.

6. Rod Cleveland moved, seconded by Darry Stacy, to **approve** the **Agreement** between The Board of County Commissioners on behalf of The County Treasurer and Official Payments Corporation to provide maintenance/services and charge Service Fees to citizens of the County for the convenience of the Customer making payments to the County by use of the Services. Service Fees on Credit Card and MasterCard Debit Card Payments for Property Tax are 2.5% with a minimum Service Fee of \$3.95 and Service Fees on Visa Consumer Debit Card Payments for Property Tax are \$3.95 flat fee. The Contract period is July 1, 2013 through June 30, 2014. (Renewable for 3 additional fiscal years.)
