MINUTES

DECEMBER 2, 2013

Rod Cleveland led in prayer and Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 2nd day of December 2013, in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. After the reading of the minutes of the Regular Meeting of November 25, 2013, and there being no additions or corrections, Darry Stacy moved to approve the minutes. The motion was seconded by Rod Cleveland.
