C. There was no new business to come before the Board for discussion.

D. Commissioner's Discussions regarding County Business:

Commissioner District #1 Rod Cleveland said that he has been in contact with Oklahoma City and they are finishing up the details on another contract for SE 149th Street. He will be contacting Norman because there is a mile of road in the Norman City limits requiring Norman to come on board with the project. At that point they can go all the way from Choctaw Road to Harrah Newalla Road with a new surfaced road in that area. Commissioner District #3 Rusty Sullivan said that it sounded like a worthwhile project. Commissioner Cleveland updated the Board on some legislation being passed into law. He said that Senate Bill 1357 is a Commissioner's right to carry throughout the State while on duty. House Bill 2367 is an increase in the travel reimbursement sealing from \$600.00 to \$950.00 for Sheriffs and Commissioners. House Bill 2348, drafted by Representative Bennett allows the display of the Ten Commandments as historical writing. He said that there is some legislation involving term limits for counties and other matters that he will continue to watch during this time of the year. He has draft legislation on the CNG proposal that has not been assigned a bill number yet, but will be by the end of the week and is anxious to see how that progresses.

E. Public Comment:

4-H & Youth Development Educator Jessie Furnish stated that they are making plans for the 4-H Day at the Courthouse again this year. She said that they have some proposed dates for the Board's consideration: March 17th, which will be during Spring Break and the students are available during that time; April 14th; April 21st; and April 28th. Following a brief discussion the Commissioners decided to pass this information on to the Budget Board members and then contact her as to the preferred date.

F. There being no further business to come before the Board, Rod Cleveland moved that the meeting be **adjourned** at 1:22 pm. Darry Stacy seconded the motion. The vote was: Darry Stacy, yes; Rod Cleveland, yes; Rusty Sullivan, yes. Motion carried.
