D. There was no new business to come before the Board for discussion.

E. Commissioner's Discussions regarding County Business:

Commissioner District #2 Darry Stacy said that the road crews are making preparations to fight wildfires should they occur. He said that Emergency Manager George Mauldin is keeping track of the situation in the County.

Emergency Manager George Mauldin said that there are several items laid out in the statutes for declaring a ban on outdoor burning based upon drought conditions to cut the threat of wildfires. He said, "We are not yet there." Mr. Mauldin added that the National Weather Service says that we are at normal levels for this time of year. After visiting with the Fire Chiefs in the County, they advised to stay ready but not issue a burn ban yet, but if conditions persist a burn ban for next week is possible.

Chairman Rusty Sullivan said that the County is taking every precaution to act on a moment's notice in case of a wildfire and are on standby and alert.

F. No comments from the Public were heard from the floor.
