### **BOARD OF COUNTY COMMISSIONER'S**

## **MARCH 24, 2014**

Paul Odom III led in Prayer and Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 24<sup>th</sup> day of March 2014 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan.
