The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 31st day of March, 2014 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. Roll was called by Tammy Belinson, County Clerk/Secretary, and those present were:
