### **BOARD OF COUNTY COMMISSIONER'S**

#### **MINUTES**

#### MAY 27, 2014

Conner Young led in **Prayer** and **Pledge of Allegiance**.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 27<sup>th</sup> day of May 2014 in the meeting Room 200 of the Cleveland County Office Building by Chairman Darry Stacy. Roll was called by Tammy Belinson, County Clerk/Secretary, and those present were:

After the reading of the minutes of the Regular Meeting of May 19, 2014 and there being no additions or corrections, Rusty Sullivan moved that the minutes be approved. The motion was seconded by Rod Cleveland.

# A. Bid Opening:

1. Upon the recommendation of Assistant Purchasing Agent Keri Lyles, Darry Stacy moved, seconded by Rod Cleveland, to award to GET Imaging Inc., the only bidder which included a properly executed non-collusion form, for Bid #CC-1675- Transfer of Imaging Computer Documents to microfilm for the County Clerk. Price per image to create original silver 16 mm microfilm: Price per image: \$0.030; Length of Reel: 215 feet and Price per image to process duplicate silver copies of processed 16 mm microfilm: Price per image: \$0.00625; Length of Reel, 215 feet; Number of images per Reel: Minimum of (3) Books per roll. The bid term will be a one (1) year non-encumbered contract from July 1, 2014 through June 30, 2015 with the option to renew up to two (2) consecutive years.

#### **B.** Old Business:

1. Upon the recommendation of Assistant Purchasing Agent Keri Lyles, Darry Stacy moved, seconded by Rusty Sullivan, to award to the low bidder Silver Star Construction Company Inc. for Bid #HWY-1674- Four Months (4) Non-Encumbered Contract to provide Material and Installation of Asphaltic Concrete Base and Surface Coarse (Hot Mix/Hot Laid Asphalt). The bid term will be from June 10, 2014 through October 9, 2014.

### C. Items of Business:

- 1. Bonnita Brakefield presented the Prudential Award to Kaylee Young. Chairman Stacy said that Kaylee Young has won the Prudential Spirit of Community Award which represents the United States largest youth recognition program, based solely on volunteer service. Seventeen year old Kaylee Young, a junior at Coach Academy and an active member of the Cleveland County 4-H Club, organized the dispersal of more than 1,800 Cool Ties that kept people cool as they cleaned up after the tornadoes that ripped through Cleveland County. Kaylee has made Cool Ties for the military troops for the past three years as well.
- 2. Rod Cleveland moved, seconded by Darry Stacy, to approve the Contract between Cleveland County Health Department and Norman Public Schools to provide instructional services for up to two children 3 years of age enrolled in the Early Foundations program for the Norman Public Schools. The Health Department will bill Norman Public Schools at a rate of \$833.00 per month for services up to three instructional assistants. Travel related to training for instructional assistants will be billed at a rate of \$0.56 per mile and shall not exceed costs authorized by the State Travel Reimbursement Act. The contract shall not exceed \$30,000.00 per program year and is to be effective July 1, 2014 through June 30, 2015. The vote was: Rod Cleveland, yes; Rusty Sullivan, abstain; Darry Stacy, yes. Motion carried.
- 3. Rod Cleveland moved, seconded by Darry Stacy, to approve the Contract between Cleveland County Health Department and Moore Public Schools to provide instructional services for up to two children 3 years of age enrolled in the Early Foundations program for the Norman Public Schools. The Health Department will bill Moore Public Schools at a rate of \$833.00 per month for services up to three instructional assistants. Travel related to training for instructional assistants will be billed at a rate of \$0.56 per mile and shall not exceed costs authorized by the State Travel Reimbursement Act. The contract shall not exceed \$30,000.00 per program year and is to be effective July 1, 2014 through June 30, 2015. The vote was: Rusty Sullivan, abstain; Darry Stacy, yes; Rod Cleveland, yes.

**4.** Rod Cleveland moved, seconded by Darry Stacy, to **approve** the **Agreement** between Norman Public Schools and Cleveland County Sheriff's Office from July 1, 2014 through June 30, 2015. Agreement is for Teaching Services at the F. DeWayne Beggs Detention Center at no cost.
