## **BOARD OF COUNTY COMMISSIONER'S**

## **MINUTES**

## MARCH 9, 2015

Rod Cleveland led in Prayer and Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 9<sup>th</sup> day of March 2015 in the meeting Room 200 of the Cleveland County Office Building by Chairman Darry Stacy. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Others present were: Assistant District Attorney Heather Darby, Assistant District Attorney Jim Robertson, Linda Atkins, Melinda Duke, Susan Reese, Bryan Jenkins, Andy Rieger, Rhett Burnett, George Mauldin, Susan Moffat and Christine Cartmell.

After the reading of the minutes of the Regular Meeting of March 2, 2015 and there being no additions or corrections, Harold Haralson moved that the minutes be approved. Rod Cleveland seconded the motion.

### A. Old Business:

Upon the recommendation of Purchasing Agent Melinda Duke, Darry Stacy moved, seconded by Rod Cleveland, to award the low bid of Johnson Controls Inc. with Option #1 and Option #2 totaling \$150,957.00 for BID#COM-1707

 The Purchase and Installation of all hardware and software for a new Access Control System for the Cleveland County Courthouse, Auxiliary Buildings and Access Controlled Parking Lots.
