The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 30th day of March 2015 in the meeting Room 200 of the Cleveland County Office Building by Chairman Darry Stacy. Tammy Belinson, County Clerk/Secretary, called roll and those present were:
