## **BOARD OF COUNTY COMMISSIONER'S**

#### **MINUTES**

## **JUNE 29, 2015**

Rod Cleveland led in Prayer and Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 29<sup>th</sup> day of June 2015 in the meeting Room 200 of the Cleveland County Office Building by Chairman Darry Stacy. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Darry Stacy, Chairman Rod Cleveland, Vice-Chairman Harold Haralson, Member Tammy Belinson, Secretary

Others present were: Assistant District Attorney Jim Robertson, Assistant District Attorney Heather Darby, Linda Atkins, Melinda Duke, Susan Reese, Brian Jenkins, Susan Moffat, Shelley Taylor, Rhett Burnett, Roger Lalli, Christine Cartmell, Michael Brestovansky and John Roberts.

After the reading of the minutes of the Regular Meeting of June 22, 2015 and there being no additions or corrections, Harold Haralson moved that the minutes be **approved**. Rod Cleveland seconded the motion.

The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

#### A. Old Business:

- 1. Upon the recommendation of Purchasing Agent Melinda Duke, Darry Stacy moved, seconded by Harold Haralson, to award as per bid summary to multiple vendors and where low bidder is not awarded there is an explanation for Bid#BE-1719 One Year (1) Non-Encumbered Contract for Building Maintenance Supplies for Cleveland County. The bid term will be from July 1, 2015 through June 30, 2016
  - The vote was: Harold Haralson, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.
- 2. Chairman Darry Stacy called for discussion of the **Insurance Proposal** submitted by Steve Owens Insurance Group for property and liability coverage and any other property and casualty insurance issues.

  Assistant District Attorney Jim Robertson addressed the Board stating that the need for the County to consider a new insurance provider arose from critical and potentially damaging changes that were implemented last year in renewal documents from ACCO, the County's current insurance provider. Concerns included ACCO's exclusion of coverage for sexual assaults, ACCO's

assertion that they are not an insurance company and are therefore not governed by the rules and regulations of the Oklahoma Insurance Commission, and ACCO's limitations of the County's legal remedies in the event of a claim dispute. Based on those concerns, this Board referred to the Budget Board for consideration of a potential change of insurance providers. The Budget Board, Jim Robertson, and Purchasing Agent Melinda Duke discussed this and the Budget Board recommended that the Board of Cleveland County Commissioners seek proposals for insurance coverage for Cleveland County. The Board of County Commissioners ultimately selected Steve Owens Insurance and Roger Lalli to explore the county's options in this regard. Roger Lalli completed this task by obtaining quotes and the lowest quote was from OneBeacon Insurance Group. Based upon, Roger Lalli's proposal from OneBeacon, Jim Robertson then advised the Board of the advantages of selecting OneBeacon as Cleveland County's insurance provider. OneBeacon is an insurance company and is governed by the Oklahoma Insurance Commission which preserves all of Cleveland County's rights and remedies. Therefore, if the county carries a policy with OneBeacon and something goes wrong all the county's legal rights and obligations are preserved in the event the county has to dispute a claim and/or pursue legal action. Whereas, ACCO has deprived the county of its rights in that respect. Furthermore, OneBeacon will provide adequate coverage for sexual assaults, one of the biggest liabilities for a county.

Upon the recommendation of Assistant District Attorney Jim Robertson, Darry Stacy moved, seconded by Harold Haralson, to **accept** the Insurance Proposal from Steve Owens Insurance Group and to **switch** to OneBeacon Insurance Group for property and liability coverage.

The vote was: Darry Stacy, yes; Rod Cleveland, no; Harold Haralson, yes. Motion carried.

### **B.** Items of Business:

1. Chairman Darry Stacy called for an update on the **Midwest Wrecking** schedule to demolish the building at 203 S. Jones, Norman, OK. He said that Bryan Gann was not able to make it to the meeting today; however, he did give the Board a memo stating that the plans are that demolition will begin on July 6, 2015 after the July 4<sup>th</sup> weekend and if there are any problems with the permitting Bryan Gann will come to the next meeting and give the Board an update as to when the actual demolition will occur.

The County Treasurer will pay for the even months and the County Clerk will pay for the odd months.
- **6. Standard Service Contract** between the Board of County Commissioners on behalf of the Cleveland County Treasurer's Office and COX Communications for Cox Business Cable Service in the amount of \$25.24 per month for the period July 1, 2015 through June 30, 2016.
- **7. Annual Maintenance Agreement Renewal** between the Board of County Commissioners on behalf of the Cleveland County Treasurer's Office and R.K. Black for service on (2) Kyocera KM5035 Digital Copiers with a per copy charge of \$0.0135 per copy (billed quarterly) for the period July 1, 2015 through June 30, 2016.
- **8. Annual Maintenance Agreement Renewal** between the Board of County Commissioners on behalf of the Cleveland County Treasurer's Office and Konica Minolta for parts, labor, drum, and supplies on (2) Konica Minolta Bizhub C452 and (5) Konica Minolta C360. Black and White copies will be billed at \$0.0071 each and Color images billed at \$0.049 each for the period July 1, 2015 through June 30, 2016.
- **9. Agreement for Services** between Cleveland County Assessor's Office and Harris Systems USA, Inc. to provide Realware Support service in the amount of \$7,500.00 for the period July 1, 2015 through December 31, 2015.
- **10. Contract** between the Cleveland County Sheriff's Department and ESW Correctional Healthcare LLC, for Medical Staffing and Administration in the F. DeWayne Beggs Detention Center from July 1, 2015 through June 30, 2016.
- 11. Contract between the Cleveland County Sheriff's Department and bfac.com to provide annual service for business texting and mobile app for an annual fee of \$3,100.00 and the Fast Track Option which is a one-time fee of \$399.00 for the period July 1, 2015 through June 30, 2016.

Service Agreement between Cleveland County Sheriff's Department and US Fleet Tracking to provide 24 hour monitoring and tracking of vehicles of the Cleveland County Sheriff at a cost of \$29.95 per vehicle per month for the period of July 1, 2015 to June 30, 2016. There will be between seven (7) to eighty (80) vehicles equipped with US Fleet Tracking modules. US Fleet Tracking will supply the necessary hardware/software modules for each vehicle at no cost to the Cleveland County Sheriff, with the agreement that if the county decides to cancel, all hardware will be returned to US Fleet Tracking.
- **13. Agreement** between the Cleveland County Board of County Commissioners and Cleveland County Pre-Trial to provide Pre-Trial release services, supervision, and electronic monitoring of persons placed on the program by a Judge of the District Court for the period July 1, 2015 through June 30, 2016 to be paid monthly with an annual fiscal cap of \$365,000.00.
- **14. Agreement** between the Cleveland County Board of County Commissioners and Oklahoma Department of Agriculture Food & Forestry Wildlife Service Division for Predator and Rodent Services in the amount of \$2,400.00 for the period July 1, 2015 through June 30, 2016.
