## **BOARD OF COUNTY COMMISSIONER'S**

#### **MINUTES**

## **JULY 13, 2015**

Rod Cleveland led in Prayer and the Pledge of Allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 13th day of July 2015 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of July 6, 2015 and there being no additions or corrections, Harold Haralson moved that the minutes be **approved**. Rod Cleveland seconded the motion.

### A. Old Business:

 Harold Haralson moved, seconded by Rod Cleveland, to table action until a later date on the Interlocal Agreement with the City of Norman for FY15-16. The vote was: Rod Cleveland, yes; Harold Haralson, yes. Motion carried.

Harold Haralson moved, seconded by Rod Cleveland, to **table** action until a later date on Agenda Items #2 and #3, as follows:

**2. Contract** between the Cleveland County Board of County Commissioners on behalf of Cleveland County District Court and First Choice Recovery for Children and Families to provide administrative and program services. Effective date July 1, 2015 through June 30, 2016; and

**3. Contract** between the Cleveland County Board of County Commissioners on behalf of Cleveland County District Court and First Choice Recovery for Children and Families to provide administrative and program services. Effective date June 1, 2015 through June 30, 2015.

## **B.** Items of Business:

1. Chuck Gann, Midwest Wrecking, updated the Board on the project to bring the building down at 203 S. Jones, Norman, OK. He said that by next week they should completely demolish the building and will continue working on hauling the debris away.

Chairman Rod Cleveland extended the Board's condolences to the family of Ben Kates, owner of Midwest Wrecking that passed away on Sunday evening after suffering a heart attack.

The parts, labor, travel and toner are covered at a base rate of \$90.00 per month and also include 3000 black and white copies and 1000 color copies. Overages shall be billed at \$.0130 for black and white and \$.0506 for color copies for the period July 1, 2015 through June 30, 2016.
