B. Old Business:

Jones, Norman, OK.
- Darry Stacy moved, seconded by Harold Haralson, to approve to Rescind & Re-award the following item on Bid #BE-1719 awarded in the June 29, 2015 meeting. Page 10A, 20" Lt. Blue Buffing Pads awarded to Empire Paper Co. for \$11.53, Empire Paper Co. mistakenly bid Cleaning pads instead of Buffing pads as requested on bid invitation. Re-award to Paradise Equipment Services in the amount of \$28.59. The vote was: Harold Haralson, yes; Darry Stacy, yes. Motion carried.
- Darry Stacy moved, seconded by Harold Haralson, to accept the Donation of a Black 3 year old Malinois "Django" to the Cleveland County Sheriff's Office from Diamond B. Malinois. Django is trained for work. The vote was: Harold Haralson, yes; Darry Stacy, yes. Motion carried.
- Harold Haralson moved, seconded by Darry Stacy, to table discussion and/or action until a later date on the Independent Contractor Agreement between The Cleveland County Board of County Commissioners and Karen Berry for service to the Family Drug Court Program in the amount of \$1,250.00 per month.

Darry Stacy moved, seconded by Harold Haralson, to approve the Change order quote from Sun Construction Services, Inc. in the amount of \$2,385.00 for additional paint and prep for the exterior of the Fairgrounds building to include all gutters, downspouts, metal trim and exterior doors. Paint all exposed gable, columns, and parapet of existing building. Original quotes for the Remodel of the exterior existing AG building at the Cleveland County Fairgrounds per Title 61, Sec. 102 & 103, were approved in the May 26th County Commissioners meeting in the amount of \$37,449.00. The vote was: Harold Haralson, yes; Darry Stacy, yes. Motion carried.
- Harold Haralson moved, seconded by Darry Stacy, to approve the 2016 Cleveland County Five Year Road/Bridge Plan for CIRB and CBRI Funds and noted that there is a Scribner's error on one of the items on District #3; the road is actually .3 miles west of 72nd Street instead of one-eighth mile as listed and the engineer will correct later. - Harold Haralson moved, seconded by Darry Stacy, to approve the Permit Application from Valor Telecommunications of Texas to place a fiber cable and boring on county road 156th Street between HWY 39 and Moffet Rd. in Cleveland County District #3.
