MINUTES

MARCH 28, 2016

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 28th day of March 2016 in the meeting Room 200 of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the regular meeting of March 21, 2016 and there being no additions or corrections, Darry Stacy moved that the minutes be approved. Harold Haralson seconded the motion.

A. Old Business:

 Upon the recommendation of Purchasing Agent Melinda Duke, Rod Cleveland moved, seconded by Harold Haralson, to table until a later date the awarding and/or rejecting of the bids for BID #HWY -1747 – One Year (1) Non-Encumbered Contract for Highway and Bridge Materials for the County Commissioners. The bid term will be from May 5, 2016 and ending on May 4, 2017.

(Note rescinding due to Conrad Fire Equipment sold the 2015 Pierce Freightliner 2 door 3000 gal pumper and will be replacing it with a 2016 model).
