BOARD OF COUNTY COMMISSIONER'S

MINUTES

WEDNESDAY, DECEMBER 28, 2016

Rod Cleveland led in prayer and the pledge of allegiance.

The regularly scheduled meeting of the Board of Cleveland County Commissioners was called to order this 28th day of December 2016 in the meeting Room 200 of the Cleveland County Office Building by Chairman Harold Haralson. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Others present were: Assistant District Attorney Heather Darby, Linda Atkins, Susan Burr, George Mauldin, Jacob McHughes, Denise Ellison, John Roberts and Susan Reese.

After the reading of the minutes of the regular meeting of December 19, 2016 and there being no additions or corrections, Darry Stacy moved that the minutes be approved. Rod Cleveland seconded the motion.

The vote was: Harold Haralson, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.

A. Old Business:

1. Upon the recommendation of Assistant Purchasing Agent Susan Reese, Harold Haralson moved, seconded by Darry Stacy, to **table** the awarding and/or rejecting of the bids until a later date for **Bid #HWY-1781-** Six (6) Month Non-Encumbered Contract for Bulk Oils, Lubricants & Antifreeze for the County Commissioners. The Bid term will be January 22, 2017-July 21, 2017.

2. Upon the recommendation of Assistant Purchasing Agent Susan Reese, Harold Haralson moved, seconded by Rod Cleveland, to award to low bidder, Noble Farm & Building Supply, in the amount of \$24,590.50 for Bid #COM1-1782 – Purchase and delivery of Building Materials to build a 30' x 60' x 16' Building for the District #1 County Commissioner. The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

Chairman Harold Haralson said that the following Items No. 1 through No. 7 are Consent Items and are routine in nature; therefore, Rod Cleveland moved, seconded by Darry Stacy, to approve the following items:

- 1. Lease Agreement between Cleveland County Health Department and Pitney Bowes. This is a renewal of a lease agreement for the postage machine in the Norman office. The first year of this agreement will be billed at \$120.72/month billed quarterly at \$362.16. The following optional renewal years will be billed at \$150.89/month billed quarterly at \$452.67. This agreement is for 1 Year from March 1, 2017 to February 28th, 2018 with the option of up to 4 additional years.
- 2. Service Contract between Cleveland County Commissioners on behalf of the Cleveland County Court Clerk and ImageNet Consulting for rental and maintenance of 1 Canon ImageRunner, Serial #TBD with Inner Fin, PCL & PS Print, Additional Memory, Utility Tray Cabinet. Rental fees of \$115.17 per month and Maintenance fees of \$29.00 per month which included 3,000 impressions per month. Overages to be billed at \$.0069 per impression. This Contract is from January 1, 2017 through June 30, 2017.
- **3.** Request for Approval of Allocation of Alcoholic Beverage Tax in the amount of \$43,410.33.
