

BOARD OF COUNTY COMMISSIONER'S

MINUTES

MONDAY, APRIL 9, 2018

Undersheriff Blake Green led in Prayer and Pledge of Allegiance.

Chairman Darry Stacy called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 9th day of April 2018 in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of April 2, 2018 and there being no additions or corrections, Rod Cleveland moved that the minutes be approved. Harold Haralson seconded the motion.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Harold Haralson, yes. Motion carried.

A. Old Business:

1. Upon the recommendation of Purchasing Agent Melinda Duke, Darry Stacy moved, seconded by Rod Cleveland, to table the awarding and/or rejecting of the bids until a later date for Bid #HWY-1842 – One-Year (1) Non-Encumbered Contract for Highway and Bridge Materials for the County Commissioners. The bid term will be from May 5, 2018 and ending on May 4, 2019.

The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

B. Items of Business:

1. Chairman Darry Stacy moved the **presentation** to the end of the meeting since the recipient is not in attendance at this time.

Chairman Stacy said that the following Items No. 2 through No. 9 are consent Items and are routine in nature; therefore, Harold Haralson moved, seconded by Rod Cleveland, to approve the Consent Items:

- 2. Standard Service Contract between the Board of Cleveland County Commissioners on behalf of the Cleveland County Court Clerk and Business Imaging Systems for maintenance services on ApplicationXtender Server 25 CC User ST #3131728, Rapid Scan Batch Scanning Software, Segate B/U Agent for SQL Server, SQL Server 2000 CAL 25-PAK, Dell Server, U Scan Roll Microfilm Scanner, Integrated All-In-One Touchscreen PC, Rack Mount System, and Tape Library in the amount of \$15,100.00 for the period July 1, 2018 through June 30, 2019.
- 3. Change Order #3 DR 4117-09 Project #9 for TJ Campbell to have additional contract duration days (28) due to days lost from inclement weather. The adjusted contract end date of April 14 2018 is under no cost change.
- 4. Contract between Cleveland County Health Department and Norman Public Schools to provide instructional services for up to three (3) children 3 years of age enrolled in the Early Foundations program for the Norman Public Schools. The Health Department will bill Norman Public Schools at a rate of \$833.00 per month for services up to three (3) children. Travel related to training for instructional assistants will be billed at the current state rate per mile and shall not exceed costs authorized by the State Travel Reimbursement Act. The contract shall not exceed \$30,000 per program year and will run from July 1, 2018 to June 30, 2019.
- 5. Contract between Cleveland County Health Department and Moore Public Schools to provide instructional services for up to three (3) children 3 years of age enrolled in the Early Foundations program for the Moore Public Schools. The Health Department will bill Moore Public Schools at a rate of \$833.00 per month for services up to three (3) children 3 years. Travel related to training for instructional assistants will be billed at the current state rate per mile and shall not exceed costs authorized by the State Travel Reimbursement Act. The contract shall not exceed \$30,000 per program year and will run from July 1, 2018 to June 30, 2019.
- 6. Acceptance of Notice to the Board of County Commissioners by Tammy Belinson, County Clerk, the 2017 Mineral Interest Report has been received from the Office of the State Treasurer. The report is available for public viewing in the County Clerk's Office as well as on the Clerk's website.
