

### **BOARD OF COUNTY COMMISSIONER'S**

#### **MINUTES**

#### **MONDAY, JUNE 4, 2018**

Jacob McHughes led in Prayer and led in the Pledge of Allegiance.

Chairman Darry Stacy called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 4th day of June 2018 in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called roll and those present were:
