

# **BOARD OF COUNTY COMMISSIONER'S**

## **MINUTES**

### MONDAY, AUGUST 20, 2018

Prayer and Pledge of Allegiance were led by Commissioner Harold Haralson.

Chairman Rod Cleveland called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 20th day of August 2018 in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

After the reading of the minutes of the Regular Meeting of August 13, 2018 and there being no additions or corrections, Harold Haralson moved that the minutes be approved. Paul Meyer seconded the motion.

The bid term will be from September 5, 2018 through March 4, 2019.

The Health Department will provide program administration for replication the Early Foundations model in Norman, OK; provide intensive service provision for individual children with Autism Spectrum Disorders; purchase classroom materials and general supplies for the implementation of the model; In-state travel as needed for the replication project. Services will be provided July 1, 2018 to June 30, 2019 and will not exceed \$20,000.00 and any pre-approved documented expenses if applicable.
