MINUTES

MONDAY, NOVEMBER 5, 2018

Prayer and Pledge of Allegiance were led by Commissioner Harold Haralson.

Chairman Rod Cleveland called to order the regularly scheduled meeting of the Board of Cleveland County Commissioners at 1:00 P.M. this 5th day of November 2018 in meeting Room 200 of the Cleveland County Office Building. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

B. Items of Business:

Chairman Rod Cleveland read the Resolution Proclaiming November 2018 as
 American Indian History Month and shared a personal story about his
 ancestral grandparents' relocation in the 1830's on the Trail of Tears and
 displayed an artwork commemorating the experience by Choctaw artist Waylon
 Gary White Deer that his father, Bobby Cleveland, had commissioned.

Honored guest, Governor Edwina Butler-Wolfe, Absentee Shawnee Tribe of Oklahoma, thanked the Board of Cleveland County Commissioners for recognizing November 2018 as American Indian History Month.

Commissioner Stacy said that Governor Edwina Butler-Wolfe is the first female Governor serving her third term. He said that she is doing an outstanding job and appreciates the opportunity to partner with her on many projects in the Little Axe area.

Harold Haralson moved, seconded by Darry Stacy, to approve the Resolution Proclaiming November 2018 American Indian Heritage Month in Cleveland County.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Harold Haralson, yes. Motion carried.

Chairman Cleveland said that the following Items No. 2 through No. 9 are routine Consent Items and that the Board will vote on Item No. 7 separately; therefore, Darry Stacy moved, seconded by Harold Haralson, to approve the Consent Items excluding Item No. 7:

- **4.** Contract Amendment Tyler Technologies for reallocating charges of \$54,825.00 from the conversion portion of the contract.
- 5. Renewal of County Bid #COM-1777 The Rental/Cleaning of new 100% cotton and new polyester/cotton blend uniforms for 1 year. The renewal period will be from November 15, 2018 through November 14, 2019. All terms and conditions will remain the same.
- 6. **Designation** of Terri Allison a Purchase Cardholder for the Cleveland County Sheriff's Department not to exceed \$5,000.00.
- 7. This item is voted on separately.
- 8. Review, Audit, Approve or Disallow Blanket Purchase Orders submitted. A report will be available for distribution at the meeting or may be obtained from the County Clerk.
- 9. Review, Audit, and approve or disallow claims for Payment of Personal Services, Travel, maintenance & Operations, and Capital Outlay. A report will be available for distribution at the meeting or may be obtained from the County Clerk.

The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

Chairman Cleveland called for a return to Item No. 7, and moved, seconded by Darry Stacy, to table until a later date discussion and/or action on Contract Amendment for additional financial signature keys for the new software system by Tyler Technologies.
