#### F. Old Business:

1. After reading of the minutes of the regular meeting of June 17, 2019, and there being no additions or corrections, Harold Haralson moved that the minutes be **approved**. Darry Stacy seconded the motion.

The vote was: Rod Cleveland, yes; Harold Haralson, yes; Darry Stacy, yes. Motion carried.

#### G. Items of Business:

1. Rod Cleveland moved, seconded by Darry Stacy, to elect Harold Haralson as Chairman for FY 2019/2020.

The vote was: Harold Haralson, yes; Darry Stacy, yes; Rod Cleveland, yes. Motion carried.

2. Rod Cleveland moved, seconded by Darry Stacy, to elect Darry Stacy as Vice-Chairman for FY 2019/2020.

The vote was: Darry Stacy, yes; Rod Cleveland, yes; Harold Haralson, yes. Motion carried.

- 3. Chairman Harold Haralson presented John Graham a Certificate of Appreciation for services rendered to District #3 by having accomplished the proper functioning of their radio system. He asked that everyone concerned come forward for a photograph opportunity under the camerawork of Joy Hampton.
- 4. Jacob McHughes made a presentation on Rapid DNA. He attended a Lunch and Learn, as requested by Tulsa County, in order that the information he received could be conveyed to the Board of Cleveland County Commissioners. The lecture topic was about Rapid DNA. The invites of the attendees were State Legislators, FBI, DOC, Tulsa County Officials, Former Colorado Assistant Attorney General, Tribal Government Officials and Law Enforcements. He stressed that the information submitted is to only inform the BOCC and is in no way an endorsement. He is merely passing the information from Tulsa County to them since they are the policy and decision makers for Cleveland County. Rapid DNA was initiated in Oklahoma by SB 184, the premise on an original act by President Trump in 2017, HR 510. Basically, the FBI issues standards and procedures on Rapid DNA. His observations at the meeting were that it speeds up the process when someone is arrested to get hits off of other crimes that these individuals have committed in other states. Oklahoma is the first state to adopt this style of law and Tulsa County has spearheaded this and they are actively trying to get this information out to other counties as to what they are doing. This will go into effect in November 2019. He said that Representative Carol Bush made the offer to come and meet with the BOCC on

this matter if interested in receiving more information on this matter. Tulsa County offered to do the same as well.

Commissioner Stacy commented that no one wants to get the bad guy more than he and spent twenty-three years doing just that. He said that the 4<sup>th</sup> Amendment was always held sacred in the course of their investigations and now it is his biggest concern. Compulsory extraction and analysis of a person's DNA prior to conviction is a search and based upon the Constitution 4th Amendment right this does not fall within any exception to the requirement for a warrant. DNA collection is a bodily intrusion on an individual's blueprint by the government. Unlike finger printing, DNA is not used as a form of identification, but rather as stated by the government only compared with crime scenes samples at this time; however, the future scientific implication of what these samples can be used for are limitless. One of the primary principles of the criminal justice system is the presumption of innocence until proven guilty. He asked at what point we draw the line in the form of intrusion of the state and federal government into our private lives. He asked if anyone in the room would give out their Social Security Number. Commissioner Stacy stated they are asking us to give out our genetic blue print to be cataloged and screened. The 4th Amendment does not allow the government to seize and warehouse our personal papers or effects just because they promise to not examine them later and the law should be no different with our genetic blue print. He said there is already a fight taking place to hold on to their Second Amendment rights and now the American people are being asked to give up their 4<sup>th</sup> Amendment rights as well. He said, "As you can see I am thoroughly passionate about this and I have personal beliefs and opinions about this that this is an intrusion on our 4<sup>th</sup> Amendment rights when we chose to do this prior to conviction." Sheriff Todd Gibson stated that he was asked to attend the lunch and learn but

Sheriff Todd Gibson stated that he was asked to attend the lunch and learn but was not available to attend the meeting. He has not received anything from Tulsa County. He agrees, philosophically, with Commissioner Stacy on this matter.

Chairman Haralson said that since Oklahoma is the first state to do this, it places them in the situation as the first ones to deal with all of the law suits that will arise.

Jacob McHughes said that he agrees with the Commissioners and having heard all the arguments from both sides in whatever interpretation of what the 4<sup>th</sup> Amendment is and the premise of what this whole thing was about which was to simply get the bad guys off of the street that had perpetrated crimes in other states. He finished by saying that his purpose was to bring to the message to the Board's attention.

5. Rod Cleveland moved to designate Harold Haralson as the Official Cleveland County Board Member to the District #5 Circuit Engineering District Board of Directors.

Harold Haralson respectfully declined and moved to **appoint** Darry Stacy to the District #5 Circuit Engineering District Board of Directors.

Darry Stacy seconded the motion.
